



Board of Directors Nominations

Nominations for the 2019-2021 CMRA Board of Directors open July 3, 2018 and close August 15, 2018.

The terms of Shandra Crawford, Danny Dominguez, and John Orchard will be expiring, so this year there are three (3) open seats and we need your help to fill these. John and Shandra have served only one term and are therefore eligible to run again for a second term. Danny is at the end of his 2nd three-year term, so is not eligible for re-election at this time. He can run again after sitting out one election cycle.

Nominees must be an Associate or Full Member, in good standing, for at least the preceding two (2) consecutive years (730 days).

CMRA members who are not eligible for nomination, based on the CMRA 2017 ByLaws, include the following:

1. A member who has been found guilty in any jurisdiction of: a felony or a misdemeanor involving moral turpitude; a violation of any law regarding the regulation of controlled substances; a violation of any motor vehicle statute for which the punishment includes possible confinement in the City or County jail or State penitentiary.
2. A member who is related to an existing Director by marriage or blood within the first degree of consanguinity, or who shares the same permanent residence or domicile with an existing Director.

Here are some of the obligations of a CMRA Board Member:

-Attendance of Meetings: Meetings are scheduled quarterly or as needed and are usually held at the CMRA office or occasionally another location central to the BoD Members. Members should expect 3-4 meetings per year.

-Event Attendance: It is preferred that members attend as many race events as possible. This will provide both an opportunity to solicit feedback from the membership and provide the background information required to make decisions that guide the club.

-Message Board: Due to the geographic footprint of the CMRA, time sensitive items will commonly be handled via the Board of Directors page on the Message Board. A Board Member is required to keep current with these items.

-Communications with the Administrative Staff and Race-Day Crew: At times the day-to-day operations of the club require correspondence with the staff and other Board Members.

-Be available for the membership: Field questions, carry requests to the Board for review and so on...

After receiving each nomination, the CMRA Administrator will send notification to the nominee requesting acceptance of the nomination and agreement to serve on the BoD for the three (3) year term if elected (or refusal to accept the nomination). Accepting nominees will have the opportunity to provide a statement and photograph to be posted on the CMRA Message Board after nominations close on the August 15th.

Ballots will be emailed via Election Buddy to all members in good standing at their last known email address on October 1, 2018. Updated email addresses must be received in the CMRA office by September 30, 2018. Any member not receiving a ballot by October 10, 2018 will need to request to have another ballot emailed to them.

Voting will be open from October 1st through October 31, 2018.
