2010 MINI-ENDURANCE PRE-ENTRY INSTRUCTIONS

YOU MUST SEND the CMRA 2010 PAYMENT FORM WITH YOUR PRE- ENTRY FORM

Team must be registered with the Team Endurance Registration form before pre-entry can be accepted.

Pre-entries are accepted for any race all year, at any time, until midnight on the Friday one week before the race weekend.

Pre-entries can be submitted for the entire season (or remaining season if submitted after the first event) at one time by checking the box under the form name at the top of the page. Season entries will not be charged until after the submittal deadline date for each race.

1. Team Information Section

- Team must be registered with the Team Endurance Registration form before a pre-entry can be accepted.
- Fill in Team Bike #, Transponder #, the name of Track and the Event Date. If there is no transponder number listed on your form, you will be assigned a rental transponder and charged the \$40 rental fee (no refunds). Enter the transponder rental fee on the **CMRA 2010 PAYMENT FORM**.
- Fill in Team Name, Team Owner, Team Captain and Phone Numbers.

2. Team Rider Information Section

- All riders must have a current Provisional Novice, Novice or Expert CMRA license. Note that Provisional Novice riders must wear a yellow jersey whenever they are on the Team Bike.
- All riders listed on pre-entry must have signature and emergency contact info on form. **Forged signatures will void pre-entry form and will result in disciplinary action per CMRA rules.**
- Minimum of 2 riders must be listed. **DO NOT LIST RIDERS THAT DO NOT SIGN THE FORM.** Additional riders may be added at the track without charge. Teams are limited to 5 riders per season; riders may not be removed from a Team once added.

3. Race Bikes Section

- Bike make, model, cc displacement and VIN number must be listed on form.

4. Release Section

- Read the release you are agreeing to when you sign this form.

5. Transponder Rental / Acceptance Agreement Section

- This Agreement applies if you rent a transponder or if a team member accepts a transponder (such as a replacement during a race) from a CMRA Official.
- Note that transponders must be returned to the Registration Desk no later than 30 minutes after the end of your last race each day even if you are using the transponder the next day.
- Transponder Rental Fee, if applicable, is entered on the **CMRA 2010 PAYMENT FORM**.
- Present your pink copy of this form to the registration desk to pick up your transponder.

6. Class Section

- Check the box indicating your Team Class. If the Team Class is changed during the season, a new Team must be created and previously accrued points will not apply to the new team.

7. Fees Section

- The Entry Fee is \$35.00 per hour of race. (For example: 4-Hr endurance x \$35 = \$140)
- Returning Class Champions receive a \$30.00 discount. Subtract on the "Discount" line.
- Enter the total amount of fees from this form on the **CMRA 2010 PAYMENT FORM**.
- Transponder Rental is entered on the **CMRA 2010 PAYMENT FORM**, not on this form.

8. Signature Line

- The form must be signed by the Team Owner or Team Captain named on the Endurance Team Registration Form.

2010 PAYMENT FORM INSTRUCTIONS

YOU MUST SEND the PAYMENT FORM WITH YOUR PRE- ENTRY FORM(S)

Pre-entries are accepted for any race all year, at any time, until midnight on the Friday one week before the race weekend. All pre-entry fees will be charged after the submittal deadline for each race.

All cancellations must be received in writing (email, fax, or snail mail) by the CMRA no later than the opening of Registration for the event entered. Cancellations will not be accepted over the phone. **Cancellations received prior to the Monday before the event will not incur any administrative charge.** All other cancellations are subject to administrative charges for refunds per the CMRA Rule Book.

Pre-Entry Forms

- Complete and sign all Pre-Entry Forms before you fill-in this PAYMENT FORM.
- If there is no transponder number listed on any Pre-Entry form, you will be assigned a rental transponder and charged the \$40 rental fee (no refunds).

1. Top Section

- Print the total number of pages being submitted, including this form, in the blank at the upper-right corner.
- **Print your name in the "FROM" space**
- Print a voice phone (NOT FAX) number where you can be reached in case of questions in the "PHONE #" space.

2. Pre-Entry Forms Section

- Use this form to pay for up to one entry form of each type listed. If you want to pay for another racer's sprint entry (other than Junior Motard) you must submit a separate PAYMENT FORM for that racer.
- Print the bike number for each type of entry in the "Bike Number" column.
- Print the total amount from the bottom line of the Fee Section of each attached form in the "Total Amount" column.
- Put a check mark in the last column for each Pre-Entry that is renting a CMRA Transponder.
- If you rent a CMRA Transponder enter \$40 on the "Transponder Rental" line. One \$40 fee covers rental for all entries.

3. Payment Method Section

- FAX entries must be paid by charge / debit card – check the box in this section and complete the Charge / Debit Card Information Section. Your card will be charged on the Monday prior to each event weekend.
- **Checks or Money Orders:** Checks on U.S. banks should be for the full amount of Total of All Fees. Canadian, Mexican or other international riders must remit by charge card, cashiers check, or money order in U.S. funds. All checks or money orders should be made payable to the CMRA. Print the check or money order number in the space provided.

4. Transponder Rental / Acceptance Agreement Section

- This Agreement applies if you rent a transponder or if you or any racer or endurance team rider accepts a transponder (such as a replacement during a race) from a CMRA Official.
- **You must complete the charge / debit card information section if you rent a transponder, even if paying fees by check or money order.** The card will be charged \$420.00 if you fail to return your transponder as required by the Transponder Rental/Acceptance Agreement.

5. Charge / Debit Card Information Section

- **Visa/MasterCard /American Express/Discover:** Circle the correct card type. We must have the complete card number, expiration date, 3- or 4-digit security code, and name as printed on the card.
- Don't forget the expiration date and security code. Declined charges void original delivery date; entry will be processed as of the date payment is made on resubmitted pre-entries. All pre-entry fees will be charged on the Monday prior to the race weekend.

6. Mail Entries

- Pre-entries must be received in the CMRA office by midnight on the Friday one week prior to the event. Fill out the charge card information or enclose your check or money order, and mail to the address at the top of the form.

7. Fax Entries

- Fax entry is for charge cards only and must include complete charge card information. All pre-entry fees will be charged after the pre-entry deadline for each race. Send your completed form via fax to 1-888-334-0166 (24-hour line). **EMAIL ATTACHMENTS ARE NOT ACCEPTED FOR ENTRY FORMS – US MAIL OR FAX ONLY.**
